Pursuant to Regulation 30 of the Listing Regulations, it is hereby informed that on Sunday, 03rd May 2026, a fire incident occurred at our Spray Drier Plant (SPD) in factory situated at 24 A & B, New Sector, Industrial area, Mandideep-462046 (M.P.)

Impact on Operations:

Fire was controlled and fortunately, there were no casualty and injury to life. However, the affected operations will be temporarily shut and shall resume upon re-installation of SPD plant within 2 to 3 months. The company's other manufacturing operations will remain unaffected.

We are currently assessing the full extent of the damage caused.

Insurance Coverage:

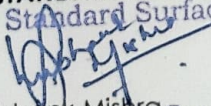
We would like to state that the Asset at the affected plant is adequately insured, and the company has already intimated the insurance company for the incident and insurance survey is expected to be conducted in due course.

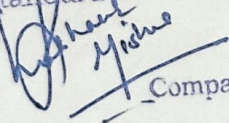
